# Articles of Incorporation

-OF-

JERSEY BAPTIST CHURCH

(Name of Corporation)

The undersigned, desiring to form a corporation, not for profit, under Sections 170.01 et seq., Revised Code of Ohio, do hereby certify

FIRST. The name of said corporation shall be Jersey Baptist Church

SECOND. The place in Ohio where the principal office of the corporation is to be located is Jersey Township, Licking County.

(City, Village or Township)

THIRD. The purpose or purposes for which said corporation is formed are:

Said corporation is formed for the purpose of providing a place of worship for its members, friends and the public, said corporation and code of regulations to conform generally with the rules, regulations, and customs of a Baptist Church and the Southern Baptist Convention; promoting the cause of the Christian religion; receiving, holding and disbursing gifts, bequests, trust funds and funds from other sources; borrowing money, executing deeds, notes, mortgages and other legal instruments; contracting with bond companies for the purpose of promoting a bond program to raise money to finance the building program or any other program of the church; building, owning and maintaining educational facilities, sanctuaries, or any other types of buildings that are necessary or incidental to the purpose of this corporation and the promotion of the Christian religion.

FOURTH. The following persons, not less than three, shall serve said corporation as trustees until the first annual meeting or other meeting called to elect trustees.

### Instructions

- 1) Profit and non-profit articles of incorporation must be accompanied by an original appointment of agent. R.C. 1701.04(C), 1702.04(C).
- 2) The statutory agent for a corporation may be (a) a natural person who is a resident of Ohio, or (b) an Ohio corporation or a foreign corporation licensed in Ohio which has a business address in this state and is explicitly authorized by its articles of incorporation to act as a statutory agent. R.C. 1701.07(A), 1702.06(A).
- 3) The agent's complete street address must be given; a post office box number is not acceptable. R.C. 1701.07(C), 1702.06(C).
- 4) An original appointment of agent form must be signed by at least a majority of the incorporators of the corporation. R.C. 1701.07(B), 1702.06(B).
